4. QUALIFICATION, EXPERTISE AND RELEVANT EXPERIENCE

In order to be eligible for participation in this tender process, prospective Service Providers must demonstrate a proven track record of providing related services and be certified by the international, regional or national equivalent quality standards. Therefore, to be eligible to participate in the tender process, Services Providers must demonstrate the following among others:

- a) Hold an internationally or national recognized certification or equivalent to related services;
- b) Have a minimum of experience of providing relevant services preferably to organization(s) of similar standing with the Contracting Authority;
- c) Clearly demonstrate their capability to meet the high-quality standard of product.
- d) The production of jersey and uniforms SHOULD be 75% produced in Timor-Leste.

The Football Federation of Timor-Leste (FFTL) requires Service Providers that demonstrate corporate vision, track record as a company, and can demonstrate that they have the facilities and resources and the capacity to produce and supply the related services.

5. CONTRACT DURATION

The contract period for this service is 3 years (2024-2027).
